







# Overview of Electronic Monitoring (EM)

#### **Definition of the Korean Electronic Monitoring Supervision**

 Electronic Monitoring supervision (EM) is a 24/7 intensive supervision program that effectively reduces recidivism by allowing probation officers to identify and track the location of high-risk offenders and those released on parole who are subject to EM order, using GPS electronic devices






- While most countries implemented Electronic Monitoring Program as an alternative to ease prison overcrowding, Korea introduced EM to prevent recidivism of highrisk offenders
- Everything related to the Electronic Monitoring Program is carried out directly by the government
- ✓ We focus on the role of probation (probation & parole) officers



#### **1** EM devices (2)

Intensified anklet type (for high-risk offenders)



- ✓ Target : re-offenders or violators of duties and obligations
- Designed to resist any attempt of illegal detachment for more than 20 minutes




### **2** Tracking Procedures



THE HAGUE

The location of offenders is determined by signals transmitted from **GPS satellites** via a mobile communications network to the monitoring center







EM Staff



- In person supervision and on-site visits
- Monitoring of compliance and revocation of probation

 Special Investigation unit of EM Supervision (SIES)




- Immediate response to alerts
  from high-risk offenders
- Conducting and investigation of a violator of conditions such as device tampering

 Being called in upon serious violations (device tampering) and arresting the violator through cooperation with the probation office



Remarkable Reduction in Recidivism






Reduction in Prison overcrowding and Costs

EM helps alleviate concerns related to prison overcrowding and the cost of incarceration

Useful Resources for Investigation and Trial

 EM provides precise and timely location data of offenders, which is used in criminal investigations, prosecutions, and trials

Smart watch type (for bail)



- ☑ 4G (LTE)
- ✓ Tampering detection
- ✓ GNSS (GPS,GLONASS),Wi-Fi
- ✓ Fully waterproofed
- ✓ Lightweight design at 90g for daily comfort and convenience



### **2** Cooperation System with Local Surveillance Center

- Electronic Monitoring Center (EMC) collaborates with local government surveillance camera control centers to detect violations of the obligations, such as device tampering or entry to restricted areas, in real-time
- ✓ This allows for prompt response and helps prevent re offending, ensuring the safety of citizens

#### Before

- Required to visit CCTV center in case of violations
- Time consuming to acquire videos, resulting in delayed response




#### After

- Direct CCTV monitoring
- Accurate situation analysis, resulting in prompt action against violations

### **3** Pretrial Electronic Monitoring on stalkers

#### October 2021, Stalking Prevention Act enacted... BUT

- ☑ Difficulty in confirming the actual access of stalkers with only restraining orders
- Series of violent crimes such as murder targeting stalking victims and their families occurred

A man, who was tracking his ex-girlfriend, discovered her parked car and then proceeded to commit murder









### **3** Pretrial Electronic Monitoring on stalkers

National outrage over stalking crimes

Social consensus on measures for victim protection



President of Republic of Korea criticizes inadequacy of stalking prevention law... calls for amendments.



We will further improve the system to ensure full protection of victims and prevent such crimes from occurring.

The Ministry of Justice revised the Stalking Prevention Act in July 2023 with a temporary measure of attaching 'location tracking electronic devices' to stalkers to secure the effectiveness of restraining orders

#### Outcome

#### Joint Declaration of Intent

WE, the representatives from the respective community corrections authorities of Australia, Japan, Malaysia, Mongolia, New Zealand, the Republic of the Philippines, the Republic of Korea, Singapore, and Thailand, gathered at the 1<sup>st</sup> Asian and Pacific Probation Conference held in Seoul, Republic of Korea on June 1<sup>st</sup>, 2023;

WELCOMING the opportunity to strengthen international partnerships and to promote mutual understanding and respect among our diverse cultures and systems; RECOGNIZING the importance of effective community corrections systems in

promoting public safety, reducing recidivism, and rehabilitating offenders;

AFFIRMING our shared perspective on developing effective crime prevention strategies and creating a safe environment for communities throughout the Asia-Pacific region; and

DETERMINED to promote and strengthen of Asian and Pacific community corrections cooperation,

Hereby issue a joint declaration as follows:

We will work collaboratively to share information, best practices, and innovative approaches to community corrections, with the goal of promoting positive outcomes for individuals and communities in our respective countries.

We resolve to continue our dialogue and cooperation beyond this conference, and to share each country's developments and achievements.

We will work collaboratively to establish an international network and to advance the development of community corrections systems in our respective countries and throughout the Asia-Pacific region.

- 1. Korean Ministry of Justice will annually gather Asian Pacific Probation Survey from participating countries, sharing the results subsequently.
- 2. Asian and Pacific Probation Conference will be held biennially, bridging the gap between the World Congress on Probation and Parole, with an expanded roster of participating countries.
- 3. The host of the next conference in 2025 will be New South Wales State of Australia.
- 4. Online meetings between practitioners from participating countries will continue to discuss survey methods and conference logistics


